Approved minutes of Minutes of Lydlinch Parish Council Meeting held on 16th March 2020 commencing at 7pm.

There were 2 members of the public present. Apologies had been received from P Batstone (Dorset Cllr)

1. Democratic period (For public comments).

Mr Lance spoke to members about the issue of speeding vehicle through Kings Stag.

2. To receive apologies.

4. To approve the minutes of the meeting 20th January 2020.

RESOLVED: The minutes of the meeting having previously been circulated to Councillors were approved and signed by the Chairman.

5. To consider the results of the speed surveys in Lydlinch & Kings Stag and give further instruction.

Of the 4 sites surveyed it was understood that Lydlinch West of Twofords Bridge did meet criteria for a SID. The figures had been summarised to show the traffic speeds at the peak traffic number points of 8am & 4/5pm. In both locations and directions in Kings Stag the majority of traffic was traveling between 30 & 40 mph. Whilst in Lydlinch (West of Holebrook Lane) eastbound the majority of traffic was traveling up to 40 mph at 8am and at 4pm the amount of traffic traveling up to 40 mph was equal to traffic was traveling between 40/ 50 mph. The cost of a speed indicator device (SID) at £3,000 plus £250 per pole and solar panels at £175 was felt to be a lot of money in relation to the total precept of £7,000. Members felt that such expenditure could only be committed to after consulting the local residents. It was noted that DC highways had offered to install some mother and toddler signs at Kings Stag.

RESOLVED:

- **To ask DC highways to install some mother and toddler signs at kings Stag.**
- **To ask Dorset Road Safely for more camera visits to Kings Stag**
- **To ask DC highways to consider having a more gradual speed change approaching the 40mph area in Lydlinch.**
