The applicant of P/FUL/2023/00451 addressed the meeting advising that they are trying to make the Green Man a more viable business and are aware of local concerns. Members of the public present expressed concerns regarding noise and light pollution overload of the sewage system and traffic generation and the potential of vehicles parking on the green at White Heart Close which is private land.

 - a. Response to DC planning consultations.

P/FUL/2023/00451 Change of use from agricultural land to camping site. Construct 11 No. bays for parking of caravans and towing vehicles. Provide electric hook up and a shower/WC block. The Green Man B3143 - Blackrow Lane To Holwell Road Kings Stag Dorset DT10 2AY

It was noted that at the time of the meeting there was one comment in support to boost tourism in the area and seven objections in relation to noise and light pollution, adequacy of sewage system, scale, traffic/highways safety and lack of information particularly in relation to noise. It was also noted that an application in 2017 for a caravan park on the site was refused and this application is for a 365-day occupancy. Whilst members appreciated the need to support local business and the concept of diversification concerns remained, reflecting the public comments.

RESOLVED: It was proposed and agreed not to support the application on the following grounds:

- Lack of information particularly in relation to noise pollution
- There is nothing in the noise assessment that addresses the potential issue of neighbour disturbance other than management by the pub.

- The use of the pub car park for access to the camping field will reduce the number of car parking spaces available and be detrimental to the business of the pub. As its stands parking for the pub is already inadequate (see Photos)
- The proposal will increase the foul and surface water drainage to a system that is already overburdened.

If the officer is mindful to grant permission members request that the application goes before the Area North Planning Committee and a site visit is carried out. Whilst members support the principle of local commerce, they suggest that applicant works with the planners to achieve an improved / scaled down scheme.

Fly tipping remains an issue at the layby on the A357 near the Kings Stag junction and the one beside the SSI site on the A3030. The idea of signs was suggested. The Clerk was instructed to contact Dorset Waste Partnership.

Pauline advised that she is a police and crime commissioner panel member. Dorset Council have a forecast overspend of 11 million which is a 1.9% overspend. Whilst there can be no reduction in funding of demand lead services, core services will be cut back. Budget workshops are taking place to look at savings and government grants. In her work on the county farm liaison panel the concept of merging smaller farms is being considered along with the impact of the changes in the dirty water regulation. Three county farms are due to be let next spring.
