<u>RESOLVED:</u> Proposed and agreed not to support the application as members are in favour of the Countryside Policy to which this application is contrary.

# 2/2018/1057/FUL Convert existing agricultural buildings to 7 No. dwellings. Plumber Farm, Haydon Downs Farm To Salkeld Bridge - Road, Plumber, Sturminster Newton, Dorset, DT10 2AG. Mr & Mrs D Cooper.

It was noted that the Parish Council had supported the previous application on the site for change of use to holiday and studio units. The applicant advised that he did not think that the previous application was financially sustainable. Members were keen to see the site tidied up and the access was considered to be adequate. It was noted that the units ranged for 2 to 4 bedroom and members did not agree with the statement made in the application with regard to the site being a non-designated heritage asset. Some members felt that whilst the 4 units in the L shaped part of the site were compliant with countryside policy in relation to conversion, it was questionable if the calf shed could be considered as such, due to its construction and that 7 dwellings on the site was too much.

## <u>RESOLVED:</u> Members support the development of the site in principal but would like to see more detail of the proposed amenity space.
