<u>RESOLVED:</u> The minutes of the meeting having previously been circulated to Councillors were approved to be signed by the Chairman at a later date.

5. Town Clerks report & Correspondence: As detailed in annex 1a. (see papers)

Correspondence had been received from Mr Mcbeath regarding speeding in Kings Stag. In relation to the issue of speeding in Kings stag in the last year the Parish Council have had representation from 2 other Kings Stag residents and one Lydlinch. In reaction to this speed limit signs had been applied on the road in both villages and a mother and toddler signs at Kings Stag. In addition a request had been made to Dorset Road Safely for more camera visits to Kings Stag and DC highways had been asked to consider having a more gradual speed change approaching the 40mph area in Lydlinch. Speed surveys had been commissioned in both villages and the following sites met the criteria for the deployment of a SID.

- Lydlinch north to south before Holebrook Lane
- Kings Stag north to south outside the memorial chapel
- Kings stag south to north before Holwell Rd

Dorset Council highways recommend that a SID is only kept at specific location for a maximum of 6 weeks and is alternately rotated. This would mean based on 3 locations that it would be at a particular location for 6 weeks and then not return after 12 weeks (3 months). The cost of having a single SID at three locations at £4,594.51 had previously been considered to be a lot of money in relation to the total precept of £7,000 and that such expenditure could only be committed to after consulting the local residents. It was noted that in the current circumstance a public meeting was not possible and a paper consultation could cost up to £400.
