Not in support

- The application is too big, represents overdevelopment of the site having a negative impact on the visual amenity of the area especially as it is close to the A357 and the A3030 junction.
- The application contrary to policy 20 as it further extends the development of the Muskets Barn site on which the dwelling is far bigger than the original footprint permitted under part Q.
- Lack of clarity and detail on the proposed use of the structure that measures 9 meters long including the extra part of 3m by 4m, which is 1.5 times bigger in length and height than expected from a normal garage structure.
- For use as a garage the design in terms of space and dimensions is not practical as the central entrance door would not allow parking for more than one vehicle in the structure unless they were parked end to end.
- The purpose of what appears to be a side room is unclear.
